- (iv) To distribute media materials to districts/ blocks/ villages.
- (v) To arrange publicity through local newspapers etc. about the survey.
- (vi) To compile and approve final list of manual scavengers for all towns/ cities/ villages in the State.
- (vii) Publication of the consolidated final list of manual scavengers in the state.
